#### **Description/Brief:**

**ECCI** is one of the University of Edinburgh's impact and innovation centres, with a successful track record in supporting low carbon businesses and providing expertise to aid the development of new low carbon products and services.

ECCI has partnered with **Climate-KIC**, the largest climate entrepreneurship network in Europe to provide support to low carbon start-ups. ECCI executes programmes that provide a handson support model with training and skills workshops, mentoring with experts, funding, industry advice and contacts in the low carbon sector.

The **Green Q** Programme is unique programme focusing specifically on Sino-European **Green** Innovation and Entrepreneurship cooperation to enable the adoption and adaption of world class green solutions into the Chinese market to accelerate the decarbonisation of the world's second largest and fastest growing economy and representing over 30% of the world's carbon emissions.

The programme's purpose is;

- To rigorously and effectively support a selected number of the best EIT Cross-KIC Accelerator Stage-3 or later start-ups to become familiar, informed and actively engaged and impactful with Chinese partners in the Chinese, Asian & Global market.
- To identify, enable and accelerate the formation of partnerships, opportunities and business engagement between Europe and Chinese organisations and their innovation and entrepreneurship ecosystems.

Green Q has been structured to provide support and guidance in advance to selected motivated high growth start-ups attempting to scale their business through partnerships in China. A tailored programme, matched with intensive support and world class facilities and logistics support will enable entrepreneurs to identify, develop and secure strategic partnerships that enable manufacturing and production, market access or technology enhancements vital to grow their core business.

Over an 8 week period, selected start-ups will receive cultural, sector-specific, legal and financial seminars, access to senior government, business and financial figures and secure three corporate placements with suitable potential partners in the greater Shanghai region.

ECCI require consultants with experience and relationships with;

- A) Relevant thematic / sectorial knowledge, workshop design, development and execution in an online format
- B) Support to shape and enable the content and delivery of the GreenQ China Conference in December

This tender is specifically for providing:

A consultant who can design and execute one or two effective 2-3 hour online workshops on behalf of our 13 start-up businesses. The themes of these workshops have been established and we are seeking a workshop focusing on;

- a) Waste, Waste Water and the Circular Economy
- b) Smart City technologies including Data, Air Quality, Mobility & Distributed Manufacturing

These workshops should be tailored towards small start-up businesses with a strong interest and limited track record in working in China. The workshops should be interactive, facilitate and encourage tailoring of knowledge delivery to the participants and feature a small number of recognised and reputable experts able to deliver clear, experience based information.

Any useful, available or tailored reports regarding the marketplace, opportunities, key actors and other useful information such as relevant policies would be seen as highly beneficial.

We would also anticipate that following each workshop, the consultant would arrange a one-to one meeting for 1 hour with each of the 13 start-up SMEs to provide an aftercare service and answer further questions.

We anticipate the consultant must take logistical control regarding the arrangements and meetings between the experts, start-ups and other actors engaged in the process and ensure an effective online communication is established and the meeting is administered.

In addition, we are seeking our consultant to provide input to enable the content and delivery of the GreenQ China Conference in December, especially accessing Chinese key note speakers and organisations to present and attend to listen to the start-up SME presentations. Essentially these will be organisations interested in the services of these start-up SMEs and the winning consultant will support positive referrals and communications between Chinese attendees and the presenting start-ups.
