Description/Brief:

The Edinburgh Climate Change Institute was established in 2010 and has consistently worked towards a climate neutral Scotland and wider world. The climate change challenge is an environmental, social and economic priority, and therefore our focus is identifying the most effective ways to accelerate action towards a thriving and sustainable Scotland.

ECCI is a centre of excellence within the School of GeoSciences, University of Edinburgh. The centre is an inclusive hub for researchers, policy makers, businesses, students and educators. As such the ECCI community includes agencies who work to tackle climate change and experienced climate practitioners working on externally funded challenge driven projects. Our community also includes students studying climate change and those that teach them. We are therefore a collective of experts who deliver research, policy, education and training.

The current excel version of the Carbon Scenario Tool has been developed in partnership with the City of Edinburgh Council and builds on existing public sector organisational carbon footprinting and project register tools to support organisations working towards area-wide emissions targets that encompass not only their corporate emissions but all of those within a geographical boundary. The tool is designed to support organisations to calculate their current and future baseline, record and model the carbon cost and benefits of different activities and to develop future low and zero carbon pathways. The tool is aimed at providing information useful and relevant to decision-makers at the point where climate change considerations can be more readily addressed in the strategy, policy and project planning process. This project is being support by the Scottish Government through the Scottish Cities Alliance and the aim of the project is to produce a detailed understanding of the requirements of local authorities and other organisations with respect to zero carbon decision-making, understand the capability and capacity of Scotland's Cities to implement such a tool and to develop a functional specification for an online version with a viable costing model.

We are looking for support to design, facilitate and report on three workshops for up to 60 participants from the Scottish Government, Cities and other public sector bodies. The aim of the workshops is to provide the context and understanding of the complex issues surrounding data-driven decision-making for climate change targets in the public sector. The workshops do not need to provide a detailed list of requirements or city capability/capacity but they need to support the future development of these detailed assessments.

ECCI require consultants with experience in facilitating online workshops around data mapping/collection. This tender is specifically for providing:

- 1) Engagement with the project team to develop an agreed outline and output
- 2) Facilitation of three *interactive* (up to 2 hours) online workshops with up to 60 participants
- 3) Post workshop report of findings

The workshops will be delivered in June – exact dates tbc. The ECCI project team will be responsible for inviting participants.

#### Core deliverables required:

Three 2-hour interactive online workshops in June 2021 (dates tbd) and a report of findings.
